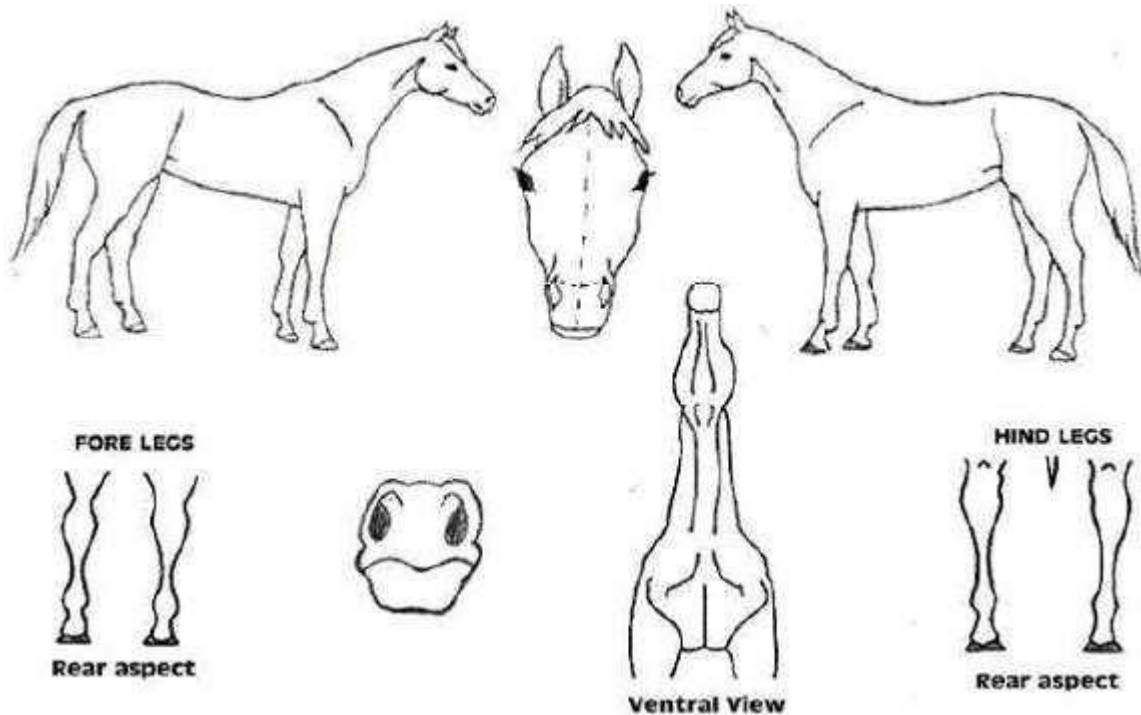

**Veterinary Attention:** All veterinary expenses will be charged to the animal's owner. Routine veterinary care will require no notification, however if a major expense is to be incurred, TEG will contact the owner.

**Payment:** All accounts and expenditures made on behalf of animals will be settled upon receipt of the duly rendered account. **TEG terms of payment are strictly 30 days of being invoiced.** An overdue account service charge of \$20.00 per month may apply on all accounts outside these trading terms. If accounts are not paid within 60 days of invoice, the outstanding account may be forwarded to a Debt Collection Agency for recovery of the outstanding monies. Collection costs will be added to the account.
